PASTOR'S NOTES

~FROM THE PASTOR~

To vaccinate or not to vaccinate? - that is the question. Our Church, much like our society, is split when it comes to the question above. Of course, the one unifying component that we all share (or at least, should share) is that we do not want abortion to be part of the equation of any vaccine that goes into our bodies; yet, we are all aware that this heinous crime, which cries to heaven for vengeance, has unfortunately too often become a part of medical science when it comes to making vaccines. So, what are we as Catholics to do? The Holy Father and our American Bishops (USCCB) have told us that we may, in good conscience, accept this vaccine. Thus, I am going to first share an excerpt from an article taken from the USCCB website which tells us more about this. My caveat to this article is: If some refuse the vaccine on the basis of use of (aborted) fetal stem cells either in the vaccine or in the testing & development of the vaccine, they are within their right to do so. There are many Catholics who say that even though the vaccine is deemed to be licit, it offends their conscience because even if the connection to an aborted baby is remote, abortion is an evil that transcends everything, and thus, they will not receive it. Our parish is a microcosm of our church and society. We must respect the choices that our fellow parishioners make without judgement or prejudice. The second piece of information that I will share gives us information on five vaccines that are currently in use or soon to be available for use, and the use of (aborted) fetal cells and their level of remoteness to the vaccine. I think that this will be very helpful, for many of you have asked for this information.

I have included the websites for both articles if you wish to read them in their entirety.

MY CATHOLIC FAITH

~FROM THE USCCB~

" ... [A]t least at present, there is no available alternative vaccine that has absolutely no connection to abortion. Second, the risk to public health is very serious, as evidenced by the millions of infections worldwide and hundreds of thousands of deaths in the United States of America alone. Third, in many cases the most important effect of vaccination may not be the protection it offers to the person who receives the vaccination, who may be of relatively robust health and unlikely to be seriously affected by the disease. Rather, the more important effect may be the protection it offers to those who are much more likely to be seriously stricken by the disease if they were to contract it through exposure to those infected. There are currently three vaccines that have been presented to us as having demonstrated their effectiveness and that are likely to be made available in the coming months, those from Pfizer, Moderna, and AstraZeneca. The situation of the first two is essentially the same. Neither Pfizer nor Moderna used morally compromised cell lines in the design, development, or production of the vaccine. A confirmatory test, however, employing the commonly used, but morally compromised HEK293 cell line was performed on both vaccines.8 Thus, while neither vaccine is completely free from any connection to morally compromised cell lines, in this case the connection is very remote from the initial evil of the abortion. ... The AstraZeneca vaccine should be avoided if there are alternatives available. ... [W] e must not allow the gravely immoral nature of abortion to be obscured. It is true that one can receive benefits from an evil action in the past without intending that action or approving of it. The association with the evil action that comes with receiving benefits from that evil action, however, can have a corrupting influence on one's perception of the evil action, making it more difficult to recognize it as evil. Experiencing the benefits that have resulted from the evil action, one might become desensitized to the gravely evil nature of that action. One might become complacent about that action and ignore the obligation to do what one can to oppose the evil action. Another consideration is the fact that one's receiving benefits from an evil action might affect how others perceive that original evil action, thereby giving scandal. Others might be less inclined to see that action as evil. They might interpret one's acceptance of benefits from an evil action

as an indication that one does not consider the action to be truly evil, which in turn might diminish their sense of the urgency of opposing that evil. They also might miss opportunities to do what they can to oppose it. In both cases, a certain complacency about that evil action could be the result. With this in mind, we should be on guard so that the new COVID-19 vaccines do not desensitize us or weaken our determination to oppose the evil of abortion itself and the subsequent use of fetal cells in research." https://www.usccb.org/moral-considerations-covid-vaccineshttps://

Pfizer: Pfizer/BioNTech's coronavirus/COVID vaccine known as "BNT162b2" was developed using genetic sequencing on computers without using fetal cells. The HEK-293 abortion-related cell line was used in the testing of this vaccine. This cell line originated from kidney cells from a fetus that was aborted in 1973. No cell line, fetal or otherwise, is required for the ongoing production of this vaccine. This vaccine is currently in use. The Pfizer/BioNTech vaccine requires "ultra-cold" storage, making distribution difficult. Currently, only hospitals and other large facilities are being consider as distribution locations for this vaccine.

Moderna: Moderna's "mRNA-1273" vaccine *does* not require aborted fetal cell lines for production, <u>but</u> aborted fetal cell lines were used in the development and testing of this vaccine. This vaccine is currently in use. This vaccine does not require ultra-cold freezers, and hence is more available in primary care offices and community clinics.

AstroZenica: The AstroZenica/University of Oxford vaccine "AZD1222" does use the HEK-293 cell line for production. This cell like was also used in the development and testing of the vaccine. The AstroZenica vaccine is currently approved for use in the UK, India, and other countries but not the United States. The US probably will not approve this vaccine until April. It does not require ultra-cool storage and is also predicted to be less expensive than other COVID vaccines, two features that may make this vaccine more widely available.

Johnson & Johnson: The J&J/Janssen COVID-19 vaccine, "JNJ-78436735" does use the PER.c6 cell line for production. PER.c6 is a proprietary cell line owned by Janssen, a subsidiary of Johnson & Johnson, developed from retinal cells from an 18-week-old fetus aborted in 1985. This vaccine will likely become available to the public in Spring or Summer, 2021. This is a single-dose vaccine, unlike other COVID vaccines which require 2 doses.

Sanofi/GlaxoSmithKline: The Sanofi/GSK "COVAX" vaccine *does not* require aborted fetal cell lines for production. GSK produces their vaccine using a modified virus cultivated on insect cells. This vaccine will likely become available to the public in Summer, 2021. The <u>HEK-293 abortion-related cell line</u> was used in the research and development of this vaccine. https://mycatholicdoctor.com/our-services/vaccines/

2021 Lenten Regulations for the Diocese of Santa Rosa

"The Lenten Season has a double character, namely to prepare both catechumens and faithful to celebrate the paschal mystery. The **catechumens**, both with the Rite of Election and Scrutinies, and by catechesis, are prepared for the celebration of the sacraments of Christian initiation; the **faithful**, ever more attentive to the Word of God and prayer, prepare themselves by penance for the renewal of their baptismal promises. (*From:* The Order of Prayer in the Liturgy of the Hours and the Celebration of the Eucharist)

The current discipline is as follows:

Ash Wednesday and Good Friday are days of *fast* and *abstinence*, that is, limited to a single, full meal and abstinence from meat.

The other Fridays of Lent are days of *abstinence* from meat.

The law of *fasting* permits only one full meal a day, but it does allow the taking of some food in the morning and a second light meal at noon or in the evening, as you prefer. Persons who have completed their eighteenth year to the beginning of their sixtieth (60) year are obligated to fast.

The law of *abstinence* from meat applies to all persons who have completed their *fourteenth* year of age. However, it is highly recommended that children from ages *seven* to *fourteen* years also follow the law of *abstinence*.

All Catholics are encouraged to receive Holy Eucharist frequently during Lent and to receive the Sacrament of Penance so that all may be prepared to celebrate more fully the paschal mystery. Those who have received their first Holy Communion are to receive Holy Communion during the Easter season.

The determination of these days of obligatory penance, as listed above, should not be understood as limiting the occasions for Christian penance. This penance is to help us see and shorten the distance between our present lives and the life God wants for each of us. "Penance should not be only internal and individual but external and social." (Constitution on the Sacred Liturgy #110)

Marriages may be celebrated with Mass and the nuptial blessing should always be given. It is, however, contrary to the spirit of penance during Lent to plan an elaborate wedding with lavish decorations.

Confirmation at the Easter Vigil: (1) Canon Law grants to pastors and parochial vicars the faculty to administer the Sacrament of Confirmation, within their proper parish, to any adult or child over the age of seven years on the occasion of his/her baptism or received into full communion with the Church. (2) Additionally, due to the Covid-19 pandemic the bishop has temporarily granted the faculty to confirm to the pastors and vicars of the Diocese. They can confirm members of their parishes. This applies to adults and to children.

Regulaciones para la Cuaresma del 2021 en la Diócesis de Santa Rosa

"El tiempo de Cuaresma tiene un doble carácter, principalmente para preparar a los catecúmenos y a los fieles para celebrar el misterio pascual. Los **catecúmenos**, con el Rito de la Elección y los Escrutinios y por la catequesis son preparados para la celebración de los sacramentos de la iniciación cristiana; los **fieles**, por una mayor atención a la Palabra de Dios y a la oración, se preparan ellos mismos por la penitencia para la renovación de las promesas bautismales. *Tomado de* El Orden de la Oración en la Liturgia de las Horas y la Celebración de la Eucaristía.

La disciplina actual es como sigue:

Miércoles de Ceniza y Viernes Santo son días de **ayuno y abstinencia**, esto es, limitarse a una sola y completa comida y abstenerse de comer carne.

Los demás Viernes de Cuaresma son días de abstinencia

Las leyes del ayuno permiten una sola comida al día pero es posible tomar algo ligero en la mañana o según se prefiera, al mediodía o la noche. Las personas en buen estado de salud entre 18 y 60 años de edad están obligadas a ayunar.

Las leyes de **abstinencia** de comer carne obligan a los mayores de 14 años. Sin embargo es altamente recomendable que niños entre 7 a 14 años también cumplan con la práctica de la abstinencia.

A todos los católicos se les recomienda recibir la Santa Comunión frecuentemente durante la cuaresma y recibir el sacramento de la Penitencia de manera que puedan estar preparados para celebrar más conscientemente el Misterio Pascual. Aquellos que han recibido su Primera Comunión, deben recibir la Santa Comunión durante el tiempo Pascual.

La determinación de los días obligatorios de penitencia, como está arriba, no debe ser entendida como limitante de la práctica de la penitencia. La penitencia es para ayudarnos a ver y acortar la distancia entre nuestras vidas presente la vida que Dios quiere para cada uno de nosotros. "La penitencia del tiempo cuaresmal no debe ser sólo interna e individual, sino también externa y social." (Sacrosanctum Concilium #110)

Los *matrimonios* pueden celebrarse con la misa y siempre se debe dar la bendición nupcial. Sin embargo es contrario al espíritu de la cuaresma elaborar las bodas con muchas decoraciones o flores.

Confirmación en la Vigilia Pascual: (1) El Derecho Canónico da a los Pastores y vicarios parroquiales la facultad de administrar el Sacramento de la Confirmación en sus parroquias a cualquier adulto o niño/a mayor de siete años quienes en ocasión de su bautismo o que están siendo recibidos en completa comunión a la Iglesia. (2) En este año, el obispo les ha dado la facultad de confirmar a los Pastores y vicarios parroquiales. Se puede confirmar a los feligreses este año.
